EVICTIONS

The successful landlord has done everything they could to avoid the eviction but, alas, it is now unavoidable because the tenant will not volunteer to give up possession and all "catch-up" promises have been broken.

- Step 1: Paperwork: Be prepared to go to the court house with the proper paperwork:
 - A. The Complaint
 - i. For possession only following termination
 - ii. For possession only failure to cure
 - iii. For possession only failure to pay rent
 - iv. For possession and money
 - B. Attached to the complaint:
 - i. Copy of lease
 - ii. Copy of the proper notice
 - a. 3 days notice for failure to pay rent
 - b. Notice of Termination (mo. to mo)
 - c. 7 days notice to cure
 - d. 7 days notice of termination (non curable)
 - iii. Copy of rent log (if evicting for nonpayment) (Suggested-Not mandatory)

- C. Separaté From The Complaint:
 - i. Non-Military Affidavit
 - ii. Stamped Envelope (large) addressed to tenant. If more than one tenant submit one envelope/tenant.
 - iii. Letter to Sheriff (see form)
 - a. Staple sheriff's check to letter
 - b. Attach map to rental house
 - iv. Two Stamped envelopes addressed to you.
 - 1: The clerk sends you copy of summons
 - 2: The Sheriff sends you proof of service

D. Checks

- i. To Clerk of Court \$185 plus \$10/tenant
 If it is a two count complaint you must
 pay the clerk of court \$185 plus \$20/tenant
- ii. To Sheriff of Volusia \$40/tenant

When you file your paperwork ask the Clerk of Court to look at your papers to see if you have any obvious mistakes or if there is anything missing.

Then you wait.

The Sheriff will serve your paperwork and mail you an affidavit of service. This will show the exact date the sheriff served the paperwork.

Mark you calendar for the 6th business day following the date of service. Do not count the day of service or Sat. Sun. or legal holidays.

On the 6th business day File:

- 1. Motion For Default (see form)
- Default (see form)Original and 2 copies with 2 SASE
- 3. Motion For Entry Of Judgment For Possession (see form) with 2 SASE
 The Clerk will prepare the Judgment For Possession
- 4. Request For Writ of Possession (see form)
- 5. Letter To Sheriff to serve Writ of Possession (see form)
- Check to Sheriff for service of writ of possession. Currently \$90 total no matter how many tenants.

The clerk will enter the writ of possession as soon as the clerk receives the Judgment for Possession signed by the Judge.

The clerk will attach the Writ of Possession to your letter to the Sheriff (with check stapled to the letter) and the next thing you hear will be a phone call from the Sheriff's Deputy to arrange a time to put you into possession.
